NOTE: As the judge's decision in the Stud Dog and Brood Bitch will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won this class.

STUD DOG CLASS - will be for Stud Dogs and at least two but not more than four of their get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their get. The owner of the Stud Dog need not necessarily be owner of the get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard for its breed. Get must be entered in a regular class, Best of Breed competition, or some other non-regular class.

BROOD BITCH CLASS - Same as above except substitute Brood Bitch for Stud Dog and Produce for Get.

BRACE CLASS: Both dogs competing must have at least one common owner. If a dog which is to be part of the brace is not entered in another class, it must be entered in "Brace Class Only", fee of \$25.00 per dog, plus the \$10.00 fee for the brace as a unit.

Open to dogs and bitches adopted through Afghan Rescue. Minimum age of each entrant is 6 months on the day of the show. Each entry will receive a Special Medallion made specifically for the PARADE OF RESCUE suspended from a red, white and blue ribbon, offered by the Afghan Hound Club of America. Contact Pamela Wall at (978) 774-8966 to be included in this event.

PARADE OF TITLISTS: Open to any & all Afghans holding titles in AKC sponsored events, including Conformation, Coursing, Obedience, Good Citizens & Performance Events.

Bred-by-Exhibitor (BBE) Class Eligibility

All dogs entered in the Bred-By class must be individually registered with the AKC

The Person handling the dog must be breeder of record of the dog and an owner of record of the dog. In any subsequent classes for which a dog from the Bred-By-Exhibitor class becomes eligible, there are no restrictions as to who may handle the dog.

JUNIOR SHOWMANSHIP

NOVICE CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show.

OPEN CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.

MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

NOVICE AND OPEN CLASS DIVIDED: Junior-9 years old and under 12 years old on the day of the show; Intermediate-12 years old and under 15 years old on the day of the show; Senior-15 years old and under 18 years old on the day of the show.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, 919- 233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

NOTE: SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S): There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show. In addition, if the dog originally entered in Jr. Showmanship was an additional entry, and the dog being NOVICE CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the substituted is not otherwise entered in the show, the Junior Showmanship Only fee applies.

PUPPY SWEEPSTAKES

Rules, Conditions, and Regulations

This Sweepstake is open to all Afghan Hound Puppies and Junior Dogs who on the day of the Show will be 6 months and under 18 months of age. The Sweepstakes will be judged prior to the regular classes

SWEEPSTAKE CLASSES ARE

Dogs - 6 months to under 9 months	Bitches - 6 months to under 9 months
Dogs - 9 months to under 12 months	Bitches - 9 months to under 12 months
Dogs - 12 months to under 18 months	Bitches - 12 months to under 18 months.

Entry fee shall be \$20.00 for each Puppy and Junior Dog and entries shall be made at the same time on the same entry form as for regular classes. Indicate Afghan Hound Sweepstakes entry in the space for "Additional Classes". All entries in the Sweepstakes must also be entered in a regular class at the regular fee.

PUPPY SWEEPSTAKES

All entry fees for puppy sweeps will be divided as follows:

50% of entry fee will be retained by the club for expenses.

First -40% of remaining entry fee in class - Second- 30% of remaining entry fee in class .

Third -20% of remaining entry fee in class - Fourth - 10% of remaining entry fee in class .

NOTICE TO EXHIBITORS

REFUNDS: Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Show Committee.

ATTENTION!! WAIVER OF RIGHTS – ANIMAL IN DISTRESS

All persons attending this dog show hereby waive any claim for damages against The Colonial Afghan Hound club or its members, in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation.

SHOW CANCELLATION: If because of riot, civil disturbances or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made.

Extreme weather conditions, such as - but not limited to - extreme heat, snowstorms, lightning or hurricanes must be considered for the health and safety of our dogs, judges, and fanciers. The well-being of dogs and participants is of paramount importance and in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.

CLOSING DATE FOR ENTRIES is 6:00 PM, May 29, 2019, Wednesday, at the Show Secretary's Home, after which time entries cannot be accepted, cancelled, or substituted except as provided for in Chapter 11, Section 6 of the Dog Show Rules.

ENTRY FORMS must be signed at the bottom by the owner or duly authorized agent, otherwise entry cannot be accepted. Entries must be on official AKC entry forms. Photocopies of entry forms without the agreement and Rules on the reverse side of the Official AKC Entry Form are **NOT ACCEPTABLE**.

CHANGES, ADDITIONS, OR CORRECTIONS must be received in writing, fax or by telegram prior to the closing date. Telephone entries are not acceptable.

ERRORS ON ENTRY BLANKS: Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.

SHOW GROUNDS WILL BE OPEN AT 8:00 A.M.

CONSULT JUDGING PROGRAM FOR TIME OF JUDGING: Dogs may arrive any time prior to their scheduled time of judging. Dogs not required for further judging will be excused.

JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS: Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

SHOW SECRETARY AND SHOW CHAIRMAN of the Colonial Afghan Hound Club will not exhibit or show any dogs.

NOTE: Effective for all shows held on or after 7/1/80, dogs which according to their owner's records have completed the requirements for a championship after the closing of entries for the show, but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed, provided this transfer is made by the Superintendent or Show Secretary 1/2 hour prior to judging at the show.

[2] The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

[4] A dog must be entered in the name of the person who actually owned it at the time entries for a show closed.
