### **SWEEPSTAKES**

The Sweepstakes is open to all Afghans who on the date of the show will be six months of age and under eighteen months of age. All dogs entered in the sweepstakes MUST be entered in a regular class of the show, and the entry form must state “Sweepstakes” (and the class division) in the space provided for ‘additional classes’. You can check off ‘SWEEPS’ at top of entry form.

### **Sweepstakes Prizes**

The Afghan Hound Clubs will retain 50% of the entry fees for expenses and the remaining monies shall be divided as follows among the class winners:

First:..... 40% of the entry fees in that class  
Second:..... 30% of the entry fees in that class  
Third:..... 20% of the entry fees in that class  
Fourth:..... 10% of the entry fees in that class

### **Non-Regular Classes Involving Single Dog Entries**

#### **Best of Breed Competition**

**Best Puppy:** Open to the dogs & bitches placing first in the Regular Puppy Classes

**Best Bred By Exhibitor:** Open to the dog & bitch placing first in the regular Bred By Exhibitor Classes

**Competitive Veterans:** Open to all **Champions of Record** who, on the day of the show, are **7 years of age or older**. Class will be divided by sex. The dog and bitch placing first in each class will be eligible to compete for Best of Breed

### **Non-Regular Classes Involving Multiple Dog Entries**

**Stud Dog Class:** For Stud Dogs and two but not more than four of their Get. Stud Dog must be entered in Stud Dog Class & must be shown in the ring with Get. Get must be entered in a regular class or in Best of Breed competition. Owner of Stud Dog need not be owner of get. .

**Brood Bitch Class:** Same as above except substitute Brood Bitch for Stud Dog and Produce for Get.

**Brace Class:** Both dogs competing in brace competition must have at least **one common owner**. If a dog, which is to be part of the brace, is not entered in another class, it must be entered for “Brace Class Only”, fee of \$25.00 per dog, plus the \$12.00 fee for the brace as a unit.

### **Parade Of Veterans (Non-Competitive)**

Open to all dogs and bitches (champions and non-champions) who, on the date of the show, are 7 years of age or older. Veterans for Parade may not be allowed to compete in any regular or non-regular class. Each entrant will receive a rosette.

Telegraph, telephone and unsigned entries cannot be accepted. Entries not on official AKC entry forms and photocopies of entry forms without the agreement and rules on the reverse side of the official AKC entry form are NOT ACCEPTABLE.

Entries received without correct fees will not be accepted. Returned checks do not constitute valid entry fees. Each returned check will have a collection fee of **\$25.00** added to it.

No Entry shall be accepted which specifies any conditions as to its acceptance. Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Show Committee. If because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

\*\*\*\* **BRED-BY-EXHIBITOR CLASS ELIGIBILITY** \*\*\*\*

The Bred-by-Exhibitor class shall be for dogs that are: Six months of age or older as of the first day of the show; Not Champions on the date of closing of entries for the show; Individually registered with The American Kennel Club as of the date of the show; Owned or co-owned by any of the breeders of record as of the date of the show. Clubs may further divide the Bred-by-Exhibitor class into two age groups consisting of **Puppy**, for dogs that are six months of age but under twelve months, and **Adult**, for dogs that are twelve months of age and older. The person handling the dog in this class must be a breeder of record and an owner of record of this dog. In any subsequent classes for which a dog from the Bred-by-Exhibitor class or divisions of it becomes eligible, there are no restrictions as to who may handle.

The RHAPSODY, a limited edition bronze, 12x12 mounted on a marble pedestal and walnut base by artist/ Afghan Hound breeder, Terry Chacon, will be awarded each year on Sunday after the Best of Breed judging by the Clubs of Summer Splash, (AHALI, Colonial, Nutmeg).

This trophy offers an opportunity for Afghan Hound owners and their dogs to be nationally recognized and become a part of a rich and documented "Summer Splash" history. This trophy shall remain property of the Clubs of Summer Splash, inscribed yearly with the winners name at the Clubs expense. A silver engraved tray and large Rosette shall be given to commemorate each win.

This award to be figured on the basis of the cumulative number of dogs / bitches defeated during the Summer Splash weekend.  
The **Winners Dog** will receive points for the number of class dogs defeated (ex. if 10 class dogs are entered he will receive 10 pts.)  
The **Winners Bitch** will receive points for the number of class bitches defeated (ex. if 10 class bitches are entered she will receive 10 pts.)  
The **Best of Breed Winner** will receive points for the dogs defeated in the Best of Breed Class only.  
The dog winning the most cumulative points shall be declared the winner.

Professional handlers, household members and current assistants  to professional handlers may not exhibit the dog in this competition.** Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and undefeated winners of the non-regular classes. This excludes all dogs defeated during class and winners competition for the regular show.

**AGREEMENT**

I (WE) ACKNOWLEDGE THAT THE Rules Applying to Dog Shows and, if this entry is for an obedience trial, the Obedience Regulations, have been made available to me (us), and that I am (we are) familiar with their contents. I (we) waive any and all claims, causes of action, I (we) might otherwise have against the AKC and any AKC-approved judge, judging at this show, under AKC Rules, Regulations and Guidelines. I (we) agree that the club holding this show or obedience trial has the right to refuse this entry for cause which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the show or obedience trial and of the opportunity to have the dog judged and to win prize money, ribbons, or trophies, I (we) agree to hold this club, its members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the show or obedience trial premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death, or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury, be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this show or obedience trial, howsoever such injuries, death or damage to property may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.

**INSTRUCTIONS**

[1] (Variety) If you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), East Windsor Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

[2] The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

[3] (Dog Show Class) Consult the classification in this premium list. If the dog show class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.

[4] A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any show for which entries closed after the date of acquisition, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
